# Erasmus+



## Student credit mobility

- All levels (short cycle, Bachelor, Master, PhD) + all disciplines
- 3 to 12 months for studies
- 2 to 12 months for traineeships  
(only from 2016 for partner countries)
- Up to 12 months per study cycle
- For staff – from 5 days to 2 months

### Erasmus quality framework

- **Erasmus Charter** for Higher Education – for Partner countries, the principles of the Charter are embedded in the inter-institutional agreements –
